**Carcinogenicity:** Titanium Dioxide is classified as IARC Group 2B. However, in lung inhalation exposure testing on

rats, mice and hamsters, tumor incidence was only observed with high-dose administration to rats. Furthermore, a similar trend is seen in rats with inert, poorly soluble particles, and carcinogenicity is thought to be influenced by the action of the rat-specific immune system. A causal relationship between Titanium Dioxide and carcinogenicity has not been displayed in human epidemiological

population studies conducted in Europe and North America.

STOT - Multiple Exposure: In a study in rats (H. Muhle) by chronic inhalation exposure to a typical toner, a mild to moderate

degree of lung fibrosis was observed in 92% of the rats in the concentration (16 mg/m3) exposure group, and a minimal to mild degree of fibrosis was noted in 22% of the animals in the middle (4 mg/m3) exposure group. But no pulmonary changes was reported in the lowest (1 mg/m3)

exposure group, the most relevant level to potential human exposures.
